Proposal

Demonstration of Sustainable Forest Management With Community participation in Nepal

Background

The community forestry programme in Nepal has positive results to rejuvenate greenery in the country, but many areas still need to be improved further mostly to generate positive social, economical and environmental impacts for the local users and for the nation. One of the major objectives of community forestry is to reduce poverty in rural villages through various income generating activities through sustainable forest management and developing community based forest enterprises.

Nepal, one of the richest countries in terms of biological diversity despite covering only 0.01 per cent of the earth's land area, has recognized 75 different vegetation types so far, ranging from dense tropical forests to alpine vegetation. The diverse ecosystems of Nepal provide a rich resource base of Non Timber Forest Products (NTFPs) and are home to 2.6 per cent of all flowering plants, 9.3 per cent of birds and 4.5 per cent of mammals inhabiting our planet. Nearly 7,000 species of higher plants are found in Nepal, of which 5 per cent are endemic to the country and 10 per cent have medicinal or aromatic properties. With this incredible richness of different flora and fauna, we have high opportunity to conserve and maintain different types of biological diversity and its components in comparison to other countries of the globe. Significant area of the national forest is currently being managed under the concept of community forestry (CF).

The Federation of Community Forestry User's, Nepal (FECOFUN) is the largest civil society organizations working on natural resource management; it has been conducting various user-friendly programs and activities particularly targeted to support the rural poor and forest dependent users. CF development sector has yet to scale up and build on lessons learned in enterprise development, promotion, value addition and local level employment creation through the sustainable management

of forest resources particularly NTFPs, for the better livelihood of the forest managers/users.

The **mission** of FECOFUN is to promote and protect the rights of community forestry users through capacity strengthening, economic empowerment, sustainable resource management, technical support, advocacy and lobbying, policy development, and national and international networking and to uphold the values of inclusive democracy, gender balance and social justice.

FECOFUN in collaboration with other stakeholders and line agencies has been implementing community-oriented sustainable forest management, enterprise development and market linkage and bio-diversity promotion programs.

FECOFUN facilitated to enhance the capacity of community forestry users groups (FUGs) to analyze and revise existing CFUGs constitutions, operational plans and other specific sub-sector plans like bio-diversity conservation, interest group management plan. CFUGs started to implement the newly adapted provisions and requested FECOFUN to include in the certification assessment process. Smartwood/Rainforest Alliance assessed 21 Community Forests (CFs) of Nepal covering more than 14,000 hectares forest according to the principles and criteria of Forest Stewardship Council (the principles covers all components of social, environmental and economic aspects) and awarded sustainable forest management certification in 2004. Federation of Community Forestry Users, Nepal (FECOFUN) has been working as the group resource manager and is accountable to the certifier in one way and it is equally responsible for maintaining the standards throughout the year.

FECOFUN as a resource manager prepared and provided guideline on protection and management of endangered flora, fauna and their habitat to all its members of the certification pool. All CFUGs have planned and implemented this guideline according to their local context. The preliminary results are encouraging and appreciative one. Users are becoming aware about the importance and consequences of loss of bio-diversity. CFUGs are becoming very serious about protection of water holes, caves, dead and dying trees, rare and endangered plants, etc.

With this FECOFUN's experience and necessity to create green jobs and improve the livelihood of the forest dependent poor people by establishing community forest based enterprises through the sustainable forest management, FECOFUN proposed the proposal on **Demonstration of Sustainable Forest Management with Community Participation in Nepal.**

Rationale

Over the last 15 years, Nepal's annual economic growth rate has averaged around five per cent or below. A close look into the components of economic growth reveals that Nepal's overall growth has derived largely from the growth of the non-agricultural sector which now contributes about 60 percent of GDP, compared to a mere 40 percent 15-20 years ago. This has transformed the structure of Nepalese economy. However, the structure of employment has not changed accordingly. About 80 per cent of the Nepalese population still works in the agriculture sector. Consequently, income distribution has become far more uneven, with severe impacts on those whose livelihoods depend on the land, rivers, and forests. Three years interim plan of Nepal government has a vision to reduce the poverty. This project will help to achieve the objective of the interim plans.

NTFPs and forest products play a significant role in the economy of rural-setting in Nepal. Thousands of tons of NTFPs are collected every year from the forest and sold in raw form without any value addition. Collection and trade of NTFPs provide important employment opportunities in the rural areas. In recent years, due to the market expansion and increased need of the local people, these resources have been heavily harvested without considering sustenance. The products move through several hands to India and ultimately to U.S. and Europe but result in very little income to local communities and uncertain quality supply to industries. Due to over and premature harvesting, some valuable NTFPs are facing threats in the wild.

About 160 NTFP traded species were generating over Rs. 2.5 billion (US \$35 million) in 2002. The Ministry of Forest and the World Bank estimated a lost opportunity in the forestry sector of about Rs. 42 billion per year. In recent

years, Nepal has become renowned as an example of community forestry. CFUGs and CF progress is remarkably successful in terms of resource conservation. CFUGs have chances to create a strong network to market their forest products profitably. There are more than 14,300 CFUGs in the country reaching out to over 1.6 million households, to which 12.5 million ha of forest land was handed over.

Nepal has lots of renewable forest resources in the forests that can be used to generate rural employment, green jobs, community enterprises development along with bio-diversity conservation and governance improvement. Sustainable forest management (SFM) and FSC certification could help manage resource in a sustainable way and link good national and international markets of the high values forest products.

The present project proposal aims at combating these alarming situations of rural poverty in Nepal through the sustainable forest management and developing community forest based enterprises which contributes to the vision of three-year interim plan of poverty reduction.

Under this project, FECOFUN intends to take the CFUGs and their community based enterprises in vertical and horizontal integration through the supply of information and responsible resources and business practices of Nepal. The project will develop and strengthen the capacity of facilitating organizations (the organizations which will be involved in project implementation particularly in districts and local level), service providers and CFUGs in the project areas to commercially manage their forest resources, facilitate the establishment of enterprises, and mobilize community fund and other resources through community development activities while not compromising on sustainable supply of forest products for subsistence use. The project will give special consideration to the marginalized people and women in the project area so that the issue of equity and social justice is properly considered.

The strategy of FECOFUN clearly quantified some of the key objectives such as supporting and facilitating the establishment of 50 community forest based enterprises /company/cooperatives focusing on rural poor and forest dependent people, supporting 200 CFUGs to develop and implement sustainable forest management plan .This project proposed to achieve the goals of FECOFUN and will

definitely generate other cross cutting benefits in the social, environmental and economic spheres.

Goal of the project

The overall goal of the project is to promote Participatory Sustainable Forest Management to improve the livelihood of forest dependent poor people.

The specific objectives of the project are:

1. To develop and implement the criteria and indicators of sustainable forest management and good governance in community forestry.
2. To improve the livelihood of the forest dependent poor people through the community based forest enterprises and green jobs.
3. To document the best practices from the piloting and influence the policy to support the sustainable forest management and promotion of community forest based enterprises
4. To develop the human resources to support the sustainable forest management, livelihood improvement, community forest based enterprises and green jobs.

Expected Outputs/Impacts

The objectives of the projects will be contributed to achieve the following outputs

Proposed Activities

Numbers of the activities are proposed under project frame to achieve the project objectives and goal (see detail in Annex- A logical formwork). The brief introduction is given below:

Objective 1: To develop and implement the criteria and indicators of sustainable forest management and good governance in community forestry

Altogether seven different activities under this objective are proposed. Development of criteria and indicators(C&I) of the sustainable forest management (SFM) and good forest governance (GG), revision of community forest operational plans and constitution based on developed (C&I) of sustainable forest management (SFM) and good forest governance (GG), Improve the constitution and operational plans of

CFUGs based on C&I of SFM and GG and Public Auditing/Public Hearing of the CFUGs are majors among them.

Objective 2 To improve the livelihood of the forest dependent poor people through the community based forest enterprises and green jobs

The proposal identified altogether five different activities under this objective. Capacity enhancement of poor people of the CFUGs and strengthen their organizational capacity including development of household level livelihood improvement plans, development of the business plans and establishment of the community forest based enterprise to focus poor and marginalized people of the CFUGs are the major among them.

Objective 3: To document the best practices from the piloting and influence the policy to support the sustainable forest management and promotion of community forest based enterprises

Two activities related to documentations and dissemination to the wide range of the audiences of best practices and lessons learned, policy analysis and case studies carried out and published in media outreach are proposed to achieve this objective. These documents will be integrated under the case study, policy analysis and media outreach programme

Objective 4 To develop the human resources to support the sustainable forest management, livelihood improvement, community forest based enterprises and green jobs. To achieve the objectives the field based local resource persons (LRPs) and center level project team will be recruited and trained with respect to the project objectives and goal. The LRPs who will be selected among the CFUGs and work with the local people will be the key elements of the project. Therefore numbers of the orientation, reorientations and facilitation skill on the SFM and GG will be carried out to focus LRP within the project farm.

Role of partner organization

FECOFUN will lead the project in a joint collaboration with other civil society organizations related to natural resource management, the expert civil society organizations will contribute in relation to technical issues like curriculum development for the trainings, base line study, forest resources inventory etc. The project also works

in coordination with government line agencies to fulfill the objectives of the Three Years Interim Plan of government.

Potential co-financing opportunities

Community Forest Users Groups (CFUGs) fund will be mobilized to establish the above mentioned enterprises. It is hoped that about 13% percent of the total cost of the project will be covered by CFUGs.

Potential risks to achieving the project objectives

Nepal is passing critical political transition; new constitutional building process is on the way. The peace process is yet to come in the conclusive end. In this context, the successful of the project is highly depends on the political situation. In case, if peace process do not come to the conclusive end, the implementation of the project will be difficult.

Operational Arrangements

Project management structure

The project will be implemented in joint collaboration in between other Civil Society Organizations (CSOs) and but FECOFUN will lead and implement the project. To implement the project through FECOFUN, a central level Department (proposed: Central Program Unit) will be set up comprises of 5 senior level staffs lead by program leader including 3 specialists. Similarly, a central level project management committee will also be formed, which will be responsible for monitoring and evaluation of project in a regular basis. Furthermore, 50 LRPs / facilitator will be recruited at the local level to facilitate the project activities at local level. Also, at the local level to bring the ultra-poor under the project Ultra-poor groups (UPGs) will be formed at local level and an enterprise will be set up including these people in each target location which definitely empower and enhance livelihoods of poorer family.

Project sustainability after the expiry of donor's funding.

Since project is aimed to target CFUGs at local level. CFUGs are autonomous entities having their own constitution and Operational plan. Hence, it is hoped that once established enterprises will get momentum even after the expiry of the project.
